Rules and Regulations

Virtual Exhibitors

1. Contract for Space and Website listings

Your signed Application & Contract to Exhibit should be accompanied by the 50% deposit for your exhibit reservation to be confirmed. All approved applications will be accepted on a first-come/first-serve basis. Website listings for Superconductor, Resonator and COSY sponsors will be included on the website upon receipt of complete payment by PANIC. The conference reserves the right to cancel all or part of the conference and shall be obligated only to return that portion of prepaid exhibit fees not expended or committed.

2. Exhibit Regulations

- A. No private functions may take place during the conference without prior consent of conference management.
- B. Material displayed must be educational in nature.
- C. At least one representative must be at the booth during all published exhibit times.
- D. You may distribute giveaways of your choice and have private drawings.
- E. Agree to abide by all laws, ordinances and regulations. Exhibitors shall not engage in illegal activities.
- F. The conference reserves the right to limit or change categories of products which may be exhibited or to prohibit any exhibit which it determines in its discretion may diminish the goodwill of the conference. If an exhibit is prohibited for these reasons the conference may refund exhibit fees.

3. Enforcement

The conference reserves the right to refuse or revoke any person or company from the exhibited area. The conference may amend, add or delete from these resolutions as it deems necessary and such shall be fully binding on exhibitors.

4. No Use of Name

Exhibitor acknowledges that the conference is the sole owner of its name and marks in any advertising or other communication. Exhibitor may not utilize the conference verification/acceptance process in any ways to state or imply an endorsement of its products or services by the conference. Exhibitor agrees to indemnify the conference from any loss or damages arising from violation of this rule or from any communication which states or implies endorsement or the exhibitor or its products or services by the conference.

5. Recording Policy

By exhibiting at PANIC, you agree to PANIC's Recording Policy. PANIC strictly prohibits the recording (photographic, screen capture, audio and/or video), copying or downloading of scientific results from the sessions, presentations and/or posters at the PANIC 2020. Intent to communicate or disseminate results or discussion presented at the meeting is prohibited until the start of each individual presentation.

Sponsorship Agreement

Cancellation Policy:

The deposit payment is non-refundable. If the sponsor cancels after September 18, 2020, 100% of the fee agreed upon in the Sponsorship Application/Contract to Exhibit will be due and payable to PANIC with the written cancellation. PANIC reserves the right to cancel and/or suspend the sponsor exhibits and/or conference if their implementation is becoming illegal, impossible, or commercially impractical because of an event of force majeure such as in particular; Flood, fire, earthquake and other natural disasters, as well as war, threat of war, civil war, military acts, terrorism, acts of or actions of the Government, curtailment of travel of attendees or participants to any event related to this contract (i) due to an outbreak of a virus, or (ii) due to an occurrence of an epidemic, or (iii) at the direction of authorities, and other circumstances which are beyond the control of the parties such as strikes, social conflicts and riots.

If cancellation occurs under this provision, exhibit fees will be transferred to the following years PANIC conference with all benefits previously agreed upon in this contract remaining in place. All rules and regulations outlined in this agreement will continue to be enforced.

Should for any reason, the 2020 PANIC conference needs to be modified to a fully virtual conference, all confirmed Sponsors at the time of such a change occurring will be notified and all existing benefits will be transferred to allow for participation in the virtual program, with the addition of any/all benefits being offered to all previously confirmed Hybrid Sponsors.
